II. Sub-Divisional Level Vigilance Committees:

1. Sub-Divisional Magistrate (or person nominated by him) Chairman

2. Labour Inspector Member Secretary

3. 3 (three) persons belonging to the SC or ST residing in Member the sub-division (to be nominated by the Sub-Divisional Magistrate)

4. 2 (two) Social workers resident in the Sub-Division (to be Member

nominated by the Sub-Divisional Magistrate). 5. i) S.D.A.O (Sub-Divisional Agriculture Officer Member

ii) B.D.Os in the Sub-Division concerned

6. One (1) person to represent the financial and credit institutions Member in the district (to be nominated by the Sub-Divisional Magistrate).

7. An Executive Magistrate to be nominated by the Sub-Divisional Member

Magistrate.

The Term of the Vigilance Committee in the Districts and Sub-Divisions shall be for a period of 2 (two) years from the date of issue of this Notification.

Each Vigilance Committee shall regulate its own procedure as provided under Section 13 (4) (a) and (b) of the aforesaid Act.
