No. LBG. 50/2014/293 : In exercise of the powers conferred in Section 3 and Section 7 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act No. 30 of 1979), the Governor of Meghalaya is pleased to appoint the following Officers as Registering Officers and Licensing Authorities under the areas as mentioned below:-

The roles and responsibilities of the Registering Officers and Licensing Authorities are as follows:

- To issue Registration Certificates to establishments in which 5(five) or more inter-state migrant workmen are employed or were employed on any day of the preceding twelve months as per Chapter II of the Act.
- To grant licences to contractors who employs or who had employed 5(five) or more inter-state migrant on any day of the preceding twelve months as per Chapter III of the Act.
- The Deputy Commissioner shall have the authority to delegate his/her duties to any Sub Divisional Officer (Civil)/Block Development Officer under his/her jurisdiction and for that particular officer to function as Registering Officer and Licensing Authority within his/her respective jurisdiction.

The Registering Officers and Licensing Authorities at Sl. Nos. (ii), (iii) and (iv) above shall be assisted by the Labour Officers at the District/Block level, respectively.

The roles and responsibilities of the Deputy/Assistant Labour Commissioners/ Block Labour Inspectors are as follows:

- To assist their respective Registering Officers and Licensing Authorities in all matters pertaining to the registration of establishments and licensing of contractors as per relevant sections of the Act and Rules, including maintaining of Office Registers, file works, etc. related to the ISMW Act.
- To ensure that wages, welfare measures and other facilities are provided to the inter-state migrant workmen.
- To ensure that proper records and registers are maintained by the establishments and contractors employing inter-state migrant workmen.
- To take action or cause to take action as per relevant provisions of the Act and Rules in case of any contravention of provisions regarding employment of inter-state migrant workmen.

This Notification shall be in supersession of previous Govt. Notifications No. LBG.211/88/Pt/II/432 dated 27th February, 2012 and No. LBG.211/88/Pt/II/538 dated 13th December, 2012.
