

**Terms of reference of the Board :**

- (1) The term of the Board shall be 3 (three) years.
- (2) The Board shall meet at least once in a quarter, at such time and place and shall observe such rules of procedure relating to the transaction of business at its meetings, as may be prescribed.

**Power and Functions :**

- (1) The Board shall perform the following functions, namely :-
  - (a) Recommend to the State Government suitable schemes for different sections of unorganized workers;
  - (b) Advise the State Government on such matters arising out of the administration of this Act as may be referred to it;
  - (c) Monitor such social welfare schemes for unorganized workers as are administered by the State Government;
  - (d) review the progress of registration and issue of identity cards to the unorganized workers;
  - (e) review the records keeping functions performed at the District level;
  - (f) review the expenditure from the funds under various schemes; and
  - (g) undertake such other functions as are assigned to it by the State Government from time to time.
