Terms of reference of the Board :-

(1) The term of the Board shall be 3 (three) years.

(2) The Board shall meet at least once in a quarter, at such time and place and shall observe such rules of procedure relating to the transaction of business at its meetings, as may be prescribed.

Power and Functions :-

(1) The Board shall perform the following functions, namely:-

- (a) Recommend to the State Government suitable schemes for different sections of unorganized workers.
- (b) Advise the State Government on such matters arising out of the administration of this Act as may be referred to it.

(c) Monitor such social welfare schemes for unorganized workers as are administered by the State Government.

- (d) Review the progress of registration and issue of identity cards to the unorganized workers.
- (e) Review the record keeping functions performed at the District level.
- (f) Review the expenditure from the funds under various schemes.
- (g) To undertake such other functions as are assigned to it by the State Government from time to time.

This is in supersession of this Department's Notification No. LBG. 70/12/445 dated 6th April, 2016.
