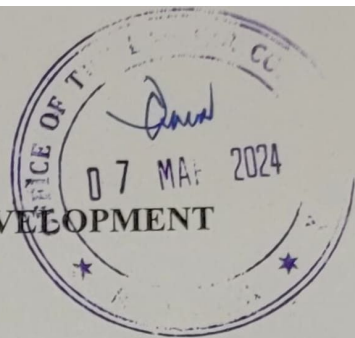

Terms & Conditions

1. The Sub-Committee should devise or workout a suitable method to fix and revise the basic rates of minimum wages, as the case may be, taking into consideration various methods/formulae as adopted by all North Eastern States and other States for fixing and revising the minimum rates of wages.
2. The Sub-Committee is to submit its reports/recommendations to the State Advisory Board within 1 (one) month from the date of issue of this Notification.
3. The Sub-Committee should hold regular meetings from time to time to address any issues relating to the fixing and revising of minimum wages in the State
