Now therefore, the Department of Labour, Employment & Skill Development has launched the **Online Single Window System** in the public domain for issuing all registrations/licences pertaining to services under various labour laws. The Department has decided to accept and implement the **Single Integrated Return under all relevant Labour Laws** through the Online Single Window System. All Contractors/Principal Employers/Establishments in Meghalaya must submit the annual returns under various labour laws through this online system.
