**No. LE&SD.50/2014:** In exercise of the powers conferred in Section 3 and Section 7 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act No. 30 of 1979), the Governor of Meghalaya is pleased to appoint the following Officers as Registering Officers and Licensing Authorities whose area of jurisdiction shall be as mentioned below:-

The roles and responsibilities of the Registering Officers and Licensing Authorities are as follows:

- (a) To issue Registration Certificates to establishments in which 5(five) or more inter-state migrant workmen are employed or were employed on any day of the preceding twelve months as per Chapter II of the Act.
- (b) To grant licences to contractors who employs or who had employed 5(five) or more inter-state migrant on any day of the preceding twelve months as per Chapter III of the Act.
- (c) To ensure that wages, welfare measures and other facilities are provided to the inter-state migrant workmen.
- (d) To ensure that proper records and registers are maintained by the establishments and contractors employing inter-state migrant workmen.
- (e) To take action or cause to take action as per relevant provisions of the Act and Rules in case of any contravention of provisions regarding employment of inter-state migrant workmen.

This Notification shall be in supersession of previous Govt. Notification No. LBG..50/2014/293, dated 2<sup>nd</sup> December, 2019.


