- 2. Initiate steps for the registration of establishments and licensing of contractors employing interstate migrant workmen as per the Inter-state Migrant Workmen (Regulation of Employment & Conditions of Service) Act, 1979 and Rules.
- 3. Submit necessary reports on the progress and implementation of various measures for implementation & enforcement of the Inter-state Migrant Workmen (Regulation of Employment & Conditions of Service) Act, 1979 and Rules in the District.
- 4. Submit recommendations to the Government on initiatives, etc. on the matter of the Interstate Migrant Workmen (Regulation of Employment & Conditions of Service) Act, 1979 and Rules as considered appropriate.
- 5. The District Level Team will meet once in every quarter.
- 6. A copy of the minutes of the quarterly meeting of the District Level Team should be forwarded to the office of the Labour Commissioner.
